3. Course Registration forms

If you haven't already, please complete the attached Course Registration form and return to Dr. Poxon ASAP! You can scan and e-mail the form back to me or take a picture and e-mail the form to me (slpoxon@henrico.k12.va.us).

A few reminders about the Course Registration forms:

- **Remember that all CFA Level I classes are DOUBLE BLOCKED** – and most of our new/incoming students have been placed in Level I. This means the class takes up two periods of the seven-period schedule. This leaves you FIVE additional classes to choose for your class schedule. If you can't fit everything in your schedule for 9th grade – don't panic! Our CFA Counselor, Ms. Kremsreiter, and our

- **In your Specialty Center selected status e-mail sent to you on March 6, you were informed about the CHANGE to the CFA Health & PE curriculum. Requirements for the Health/PE course for ALL CFA Performing Arts students have recently been changed to align with graduation requirements.** Please see the attached flyer listing the options for completing the Health/PE requirements.

Please note that you may not be able to fit the Health & PE course in your schedule during your 9th grade year. Again, don't panic! Ms. K and our HHS Counseling team will make sure that you take both Health & PE 9 and 10 at some point during your four-year career at Henrico High School! It is not a requirement that you take Health & PE 9 specifically during 9th grade (same goes for PE 10) – you just need to take it at some point during your four years of high school so that you can graduate! I know some of you are asking about summer school options – at this time, to the best of my knowledge, the county has not made a decision regarding summer school just yet. We will be sure to let you know via the CFA Newsletters once we learn the county's decision regarding summer school.
